The **Bilingual Analyst, International**, works on the management of the international education brand, in collaboration with Global Affairs Canada (GAC). In particular, the Analyst is responsible for the administration of the EduCanada brand and for ensuring it is allocated to eligible educational institutions and nongovernmental organizations (NGOs) across the country.

The successful candidate will provide and monitor monthly brand-training webinars; manage databases, e-platforms, and contractual licensing agreements; and provide support to relevant committee meetings. The Analyst will also consult with federal-provincial/territorial interested parties about the international education brand policies and will provide recommended options for discussions by the federal-provincial/territorial committee members. The analyst will also be responsible for the Asia-Pacific Economic Cooperation (APEC) and the Organization of American States (OAS) files, as well as for preparing briefing materials for meetings and webinars of other organizations, including UNESCO, as required.
